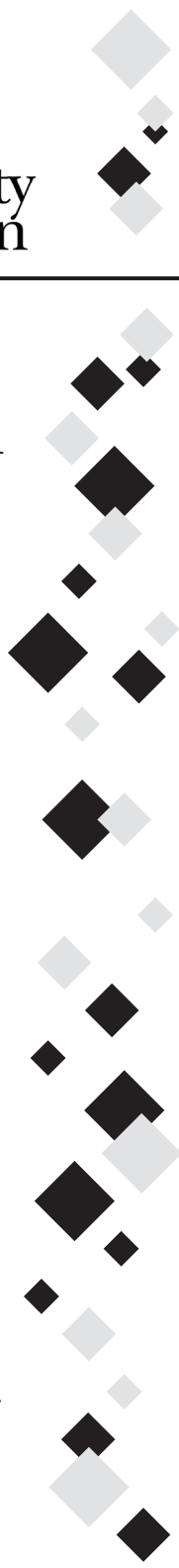

GALA 2025

GALA 2025 is a fundraising event for the communities of Sarpy and Cass counties. Each year, the Foundation honors an individual or individuals who have contributed significantly to Sarpy and Cass counties, and to the mission of the Foundation. The 2025 Reflection Award recipients are **Nancy and Jim Thompson** for their outstanding leadership and dedicated volunteer service in our community.

Jim graduated from the University of Notre Dame with a Bachelor's Degree in Business Administration and received his Master's Degree in Business Administration from Creighton University. Nancy received her Bachelor's and Master's Degrees in History from Creighton University.

Both Nancy and Jim were educators in their early careers, and they served on the committee that chartered the Papillion La Vista Schools Foundation in 1986.

After a career in education, Jim worked at Pinnacle Bank in Papillion, retiring after 28 years. Jim was elected to the Papillion La Vista School District's Board of Education, the Learning Community of Douglas and Sarpy Counties, and the Sarpy County Board of Commissioners. He was a member of the committee that established the Sarpy Community YMCA, and has been an active member of the Papillion Area Lions Club for more than 40 years.

After concluding her career in education, Nancy became the first woman elected to the Sarpy County Board of Commissioners, and then served in the Nebraska State Legislature between 1997-2006. Nancy also served on the staffs of U.S. Congressman John Cavanaugh and Nebraska Governor Ben Nelson. She later served as CEO of Big Brothers Big Sisters of the Midlands, and then as CEO of the Health Center Association of Nebraska until her retirement.

Nancy and Jim have been married 54 years and have been blessed with four children and eight grandchildren.

Honorary Chairs for GALA 2025 are **Michelle and Doug Kindig**. Michelle attended Rutgers University and completed her Computer Science and Math Degrees at UNL. Michelle has worked in IT for over 40 years, primarily with financial organizations. Doug works at Five Points Bank, and has held various government positions with the City of La Vista since 1994. He was elected as the Mayor of La Vista in November 2005 and has served in that position since that time. Michelle and Doug enjoy spending time with their nine grandchildren.
